The pandemic has affected all of our lives in ways that no one could have imagined and has brought new challenges for each of us. At Financial Security Credit Union, we are continuing to explore new ways to provide you options to safely access your accounts and conduct transactions whenever and wherever you need. Since we last visited, we have been able to achieve the following:

- Upgraded our Diamond Shield Checking account to the new and improved Diamond Shield Club account. This account offers the identity protection and cell phone coverage you have come to trust, but now also has a financial wellness platform, roadside assistance, shopping rewards, and travel, leisure AND health discounts;
- Complete a successful conversion to our new virtual branch web page VB Next, which includes a real-time upload to Excel and a variety of additional online forms, such as travel notifications, statement reprint request, and stop payment orders, just to name a few;
- > Refine our paperless processes within our lending department;
- Customize the look and feel of our mobile app, initiating ease of use and allowing for additional features:
- > Expand our commercial loan portfolio;
- Add debt protection to our suite of lending services to provide for our members when they are at their most vulnerable. The protection includes a life and disability benefit and involuntary unemployment benefit. We cab now cover events such as terminal illness, family medical leave, hospitalization and much more;
- And finally, we were able to complete a project to upgraded internet service to our south branch location for faster, more reliable service to our members.

This year, Financial Security Credit Union celebrates 67 years of service to the Eddy County community. In this time of disruptions, we are grateful for your trust and patience as we work to serve you during these challenging times. As your financial partner, we continue to be dedicated to serving you and helping you reach your financial goals, just as we did in the beginning.

Treasurer's Report

Financial Security Credit Union experienced strong financial growth in 2020 and ended the year with a capital ratio of 12.39%. At quarter-end, September 30, 2021, capital is 12.40%, which remains strong as determined by standards set by our regulators. At year-end, 2020, the credit union was \$53M in assets. Since this time, we have grown an additional 2.17% and currently sit at \$54.8M in assets. The Board of Director's continues to monitor Asset Liability Management through our ongoing association with Catalyst Corporation Federal Credit Union.

As we continue to recover from the events of 2020 that created economic challenges for everyone, we are committed to strategies that strengthen our financial position and protect assets so we can continue to provide the products and services members value most.

Supervisory's Report

The purpose of the Supervisory Committee is to protect the member's assets, ensure accurate records and maintain quality systems of checks and balances. The committee utilizes the support of an internal Supervisory auditor, strictly following an audit plan, to review selected credit union processes on an ongoing basis.

The Committee oversees that credit union operations are conducted in accordance with credit union governing rules and regulations. The Supervisory Committee retained the services of Waypoint Financial Services, LLC to complete the following audits:

Automated Clearing House as of December 31, 2020 Bank Secrecy Act as of December 31, 2020 Agreed Upon Procedures as of December 31, 2020

Further audits were completed by Cornerstone Resources:

IT, Cyber, and Physical Security Audit, including

Vulnerability Test as of September 21, 2020 Member Statement as of June 30, 2020

And finally, an examination of record was performed by the Financial Institutions Division for the State of New Mexico, qualifying the safety and soundness of the credit union as of March 31, 2021.

Based on information gathered from these external audits and examinations, as well as our own internal audits of credit union, it is the opinion of the Supervisory Committee that Financial Security Credit Union is conducting its affairs in a fiscally responsible and sound manner to protect the interest of its member-owners.

President's Report

On behalf of the entire staff of Financial Security Credit Union, let me begin by saying, "Thank you". Thank you for believing in us during such trying times. Thank you for trusting us to provide you the products and services you needed to care for your family and finances. Thank you for staying strong; as together we are better than divided apart.

2020-21 was an exciting year, where we made several advances in credit union services:

First and foremost, FSCU's first priority was to provide help to our members, where needed. We established two permanent "at home" offices, so we would never have to cease service to our members. A third office was designed to "float". Through the pandemic, with these **three at-home offices**, we were able to provide uninterrupted service and lending to our members.

Furthermore, FSCU participated in the Small Business Administration's **Paycheck Protection Program**, helping our small business owners with emergency funds. For our consumer borrowers,
FSCU completed 31 **pandemic loans** to help our members who were adversely affected by Covid-19,
and we were able to **extend payments on \$6.2M dollars in loans**.

Within our lending department, the **Commercial Loan** portfolio continues to grow. FSCU also completed an upgrade to our web page (finseccu.com), which included the addition of a **full lending application with upload capabilities**.

Among other achievements within the lending department would be the initiation of our new **Debt Protection** product. This product contains enhancements such as:

Life Plus Coverage, with no age maximum and no health questions.

Includes Accidental Dismemberment; Terminal Illness; Family Medical Leave,

Hospitalization; and Loss of Life of Non-Protected Dependent

Disability Coverage

Involuntary Unemployment Coverage

Other services new to FSCU this year include:

*Merchant Services for our small to medium size business owners. With this service, FSCU can now provide our business members with state-of-the-art "Clover" Point of Sale and Business Management Solutions, making merchant payment acceptance much easier. "Clover" offers more than 450 apps to help businesses streamline their payroll, taxes,

inventory management and more all through their "Clover" device.

*An upgrade to our mobile application, now featuring our **Mobile Branded App**.

*The conversion to our new virtual banking platform, now called **VB Next.** The new platform now includes the following **online forms** for your convenience:

Travel Notification and More

Internally, we have had system upgrades that will help us to better serve you. Like,

- *Upgrades to our **branch internet service**, both on the primary and secondary service.
- *Upgrade to an **Enhanced EPOC** to provide a more pleasant debit card experience.
- *And additions to our in-house **security monitoring** systems.

In our community, FSCU has been out and about.

In August, 2021, FSCU held our **2nd Annual Charity Golf Tournament** benefiting the New Mexico Credit Union's Connected Academy. The Connected Academy provides education to the patients at UNM Children's Hospital, and their siblings, with an accredited full-time educator. This is a state-accredited, year-round elementary and high school, which operates in a hospital setting, using material from the child's specific school.

FSCU also continues to provide **Banzai Financial Literacy** to all Eddy County schools/teachers. Banzai is an award-winning, interactive content platform that teaches real-world finance.

In August, 2021, FSCU awarded \$4,680 to two Eddy County non-profits through our on-going "Be Known for Something" campaign. Over the last seven years, FSCU has awarded over \$22,000 into our community through this program.

On the legislative/regulatory front, FSCU will continue to fight for protections for our members.

- *Taxation of your credit union dollars. A tax on credit unions is just another tax on over 100 million Americans who use those credit union services and we will continue to fight to protect your dollars.
- *Under the Biden administration's **American Families Plan**, there is a proposal which would require financial institutions to report to the IRS on all deposits and withdrawals, through business or personal accounts, worth more than \$600, regardless of tax liability. FSCU will continue to monitor this proposed piece of legislation and we will be prepared to take action, if and, when necessary.

So, what does the future hold for FSCU? -- Only good things:

- *A conversion to an improved core system enabling us to provide even more services.
- *Further upgrades and enhancements to our web page.
- *A fully automated, paperless, new account platform.
- *Electronic delivery of notices, flyers and brochures.
- *Initiation of a digital wallet.

I speak for the entire staff and volunteers when I say it is an honor to represent you.
